Committee Update

State Trophies and Pay Outs

- Develop a base for guidance for state shoot trophies and pay outs
- Association pays \$4500.00 to off set trophy and scorekeeper but club can spend more
- Club is responsible for picking trophies
- Board provides one “go to” person for trophy distribution
- Clarify out of state main winnings
- Handle subsidized as concurrent only
- Prize money same as trophies
 - “go to” person to assist
